- Extinguishing media** : All extinguishing media can be used.

6. ACCIDENTAL RELEASE MEASURES

- Clean up method** : Do not flush with water. Dam up. Soak up with inert absorbent material. If liquid has been spilt in large quantities clean up promptly by scoop or vaccum. Keep in suitable and closed containers for disposal. After cleaning, flush away traces with water.

7. HANDLING AND STORAGE

- Storage** : Store in cool & dry place with enough ventilation. Do not store above 30 deg C and below 10 deg C.
- Shelf life** : 6 months from month of Manufacturing if stored as above. Keep the container tightly sealed after every use.
- Handling** : Do not get in eyes. Keep container closed. Use with adequate ventilation. Wash thoroughly after handling.
